We are writing to you about the political situation in Sri Lanka.

As you know, after ruling in coalition for two years, on October 26th President Maithripala Sirisena fired Prime Minister Ranil Wickremasinghe in order to establish Mahinda Rajapaksa, the former President who was deposed by Maithripala Sirisena and Ranil Wickremasinghe, as Prime Minister.

This decision is incredibly controversial and appears to be in contravention of the Sri Lankan Constitution. Furthermore, protests between the supporters of the respective politicians have already broken out, resulting in the death of one protestor so far.

We are concerned that matters are escalating, as President Sirisena has suspended the Sri Lankan Parliament following attempts by Ranil Wickremasinghe to call a vote on his removal. Given the UK Government's long history with Sri Lanka, We would be grateful if you could outline the UK Government's assessment of events in Sri Lanka. Please outline steps the Government is taking to call for political stability in Sri Lanka.

The members of the 'APPG for Tamils' have been instrumental in initiating many debates and bring awareness to British Parliament on matters affecting the Tamil speaking people in Sri Lanka. Please can you also outline what discussions have been held with international counterparts regarding these events, and we would in particular like to know if this issue has been discussed with the Chinese and Indian Governments?

As President for ten years, Mahinda Rajapaksa oversaw the end of the 27-year Sri Lankan civil war in 2009 through a series of brutal military offensives in which the UN estimates up to 40,000 Tamil civilians died. This also led to many accusations that his security forces were behind the forcible disappearance, torture and murders of activists and dissidents.

Following a landmark UNHRC investigation in 2015, Sri Lanka agreed to a number of recommendations addressing previous right abuses, made in UN resolution 30/1, which so far have not been fully met. We are deeply concerned that the likelihood of justice being achieved for victims of the Sri Lankan civil war will be drastically reduced by Mahinda Rajapaksa's return to power. We would also be grateful for the UK Government's assessment of this matter.

A large proportion of the Tamil diaspora lives in the UK, including many in our constituencies; the thought of Mahinda Rajapaksa becoming Prime Minister causes great distress for Tamils in the UK and back in Sri Lanka. The threat of Mahinda Rajapaksa stoking nationalist divisions in Sri Lanka which previously fuelled the decades long civil war is very real and must not be dismissed by the international community. We therefore believe that it is vitally important that the UK Government outlines what steps it will take in order to prevent this political crisis from turning into a widespread outbreak of violence and we would therefore like to know if you have any plans for either yourself or the Minister of State for Asia and the Pacific to address the House at the earliest opportunity. Failing this we would be grateful if you could meet with Parliamentarians on the APPG for Tamils to discuss this matter.
